INVITATION FOR BIDS

Loan No. and Project Title: 2170-MLD, RDPII, Environmental Infrastructure and Management.

Contract package: FONA/WW/01, Design, Supply and Install on Turnkey Contract basis for Sewerage, Sewerage Pumping Stations and Wastewater Treatment Plant (305 m³/day) and Allied works in L.Fonadhoo Island, Maldives.

1. The Government of Maldives has received a loan from the Asian Development Bank (ADB) toward the cost of Environment Infrastructure and Management Project for RDPII, and it intends to apply part of the proceeds of this loan to payments under the contracts stated below in the table.

The Government of Maldives, represented by Ministry of Finance and Treasury (MOFT) on behalf of Project Management Unit (PMU) of RDP-II, Ministry of Housing, Transport and Environment (MHTE), now invites sealed Bids from eligible Bidders for the works given below. Bidding is open to all bidders from eligible source countries of the ADB who fulfill qualification requirements given in Section 3 of Bid document, briefly stated below.

The Bidding document, in the English language, maybe purchased by interested Bidders on the submission of a written application to the Director General and upon payment of a non-refundable fee of US\$250.00 (US dollar two hundred and fifty) in cash or by demand Draft in favor of MOFT, Maldives during normal office hours on all working days from 19th January 2010 to 9th March 2010. The bidders who desire bid document through courier will have to pay US\$10.00 or its equivalent in MRF extra in Maldives and US\$40.00 extra for outside Maldives as courier charges. The employer and or his representative will not be responsible for postal delay if any for any reasons thereof.
6. Pre-bid meeting will be held on 11th February 2010 at 1400 hours at Tender Evaluation Section, Ministry of Finance and Treasury.
7. Bids must be delivered to the address above on or before 9th March 2010- 1400 hours. All bids must be accompanied by a Bid Security of US\$25,000.00 (US dollar twenty five thousand) or its equivalent in Maldivian Rufiyaa, valid 28 days beyond the original validity period of the Bid. Late bids shall be rejected. Technical Proposals of Bids will be opened at 1430 hours on 9th March 2010 in the presence of the Bidders' representatives who choose to attend. Price proposals of technically compliant bids will be opened subsequently at a date and time to be intimated subsequently by MOFT.
8. MOFT will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
